
I would like to know when you are going to have the Schiller's "William Tell" this year. We would make a weekend trip out of it, say leave here Sat. am and return Mon. pm.

In reply to your letter of the 3rd regarding rooms for Labor Day weekend I am sending you the following information:

Our motel units are divided between the Alphorn and the Mansion and the buildings are about 8 blocks apart.

The rooms have one double bed, or a king size bed, or two double beds. So, some rooms accomodate 2 people, while others accomodate three or four.

At the Alphorn the rates are: \$14.00 for 2, and \$2.00 for each additional person. At the Mansion units, the rates are: \$16.00 for 2 and \$2.00 for each additional person.

Unless your group can arrange for 3 or 4 people to use the larger rooms, our motel would not be large enough for your group. In that case, Madison would be your best bet. It is 25 miles north of New Glarus and has several large motels. For the Labor Day weekend we do not take reservations for less than two nights.

Also, for your information, the Mansion is a restaurant, with bar and indoor swimming pool. Arrangements can be made for your group to have one or more meals there.

I hope this information will be helpful to you. Should you decide to make reservations here, I would suggest that you call me (Mrs. Bayrhofer (608) 325-4138) as our rooms are often reserved early for this particular time because of our closeness to New Glarus.

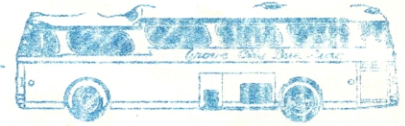

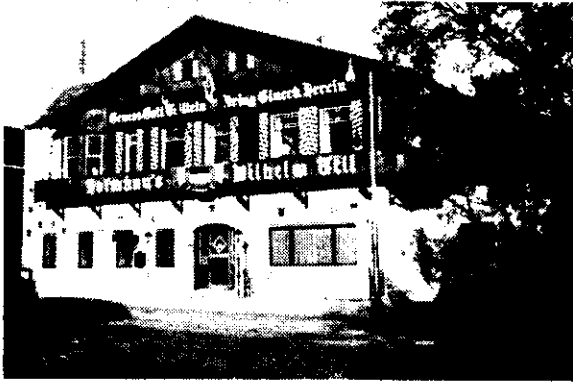

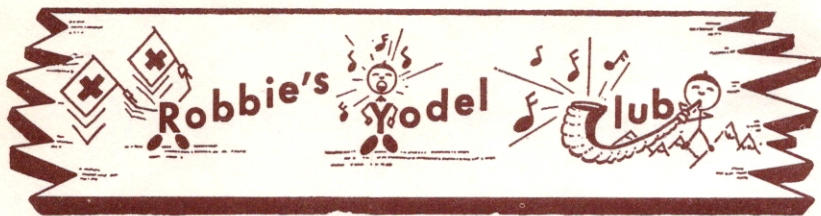

CONSTITUTION
of the
UNITED SWISS CLUBS OF THE EAST COAST, USA.
Organized in December 1961
in the District of Columbia

Article I. Name, Seat and Purpose.

- A. The name of this organization shall be United Swiss Clubs of the East Coast, USA, and it shall have its seat in the City of Washington, District of Columbia.
- B. The purpose of the United Swiss Clubs of the East Coast, USA, shall be the promotion and the fostering of social contacts among its members and the improvement of contacts between members of Swiss Clubs in the eastern part of the USA and Switzerland.

Article II. Membership, Admission, Organization and Dues.

- A. Any Swiss Association in the eastern part of the USA and individuals being members of one of the affiliated clubs of the U.S.C. may become a member of the United Swiss Clubs of the East Coast, USA.
- B. Each individual member of an affiliated Club is considered a member, having one (1) vote. The Presidents of the affiliated Clubs or their authorized agents shall represent the members at the annual meeting.
- C. In order to keep expenses as low as possible, the business of the Club shall be transacted through the Presidents (or their authorized agents) of the affiliated Swiss Clubs.
- D. The annual dues covering the period of Jan. 1 - Dec. 31 shall be fixed by the annual meeting and are to be collected by the Presidents, or their authorized agents, of the affiliated clubs.

Article III. Meetings.

- A. The Annual Meeting shall be in June of each year, and the following shall be the order of business:
 - 1. Opening
 - 2. Presentation of the Annual Report by the President
 - 3. Presentation of the Annual Report of the Treasurer
 - 4. Presentation of the Auditors' Report
 - 5. Election of new officers
 - 6. Discharge of old officers and installation of new officers
 - 7. New business.
- B. Other meetings may be called on demand by at least 150 members, representing at least 1/3 of the affiliated clubs or by the Executive Board.

Article IV. Executive Board.

- A. The Executive Board shall transact the business of the Club with the approval of the members.
- B. The Executive Board shall consist of the following officers:
 - 1. The President, who shall preside at all meetings and carry out the wishes of the majority of the members. He shall name all special committees not otherwise provided for herein. He shall call a meeting of the Executive Board whenever he or any member of the Executive Board deems it necessary. Official documents shall be signed by him for the Club. In case of a tie vote, the vote of the President decides. He shall also render the annual report to the Club members.
 - 2. The Vice President, who shall perform the duties of the President in case of his absence.
 - 3. The Secretary, who shall make a report of all activities of the Club, attend to all correspondence, render all reports of interest and benefit to the Club, and act as secretary at all Executive Board meetings. He shall keep an accurate membership list. He shall sign all official documents, together with or for the President.
 - 4. The Treasurer shall collect all dues and keep an accurate account of all financial transactions. It is his duty to give a report of the accounts and disbursements to the Club upon request, and a complete yearly report at the Annual Meeting. The books shall be open for inspection at all times to the Executive Board and the Auditors.
 - 5. The Chairman of Entertainment, who shall arrange for some form of entertainment at meetings.
 - 6. If business allows, it is possible to combine the functions of the Secretary, the Treasurer and the Chairman of Entertainment in one person.
- C. The following additional officers (not members of the Executive Board) shall also be elected: One auditor, who shall supervise the finances of the Club and examine the financial books and the annual finance report.

Article V. Election of New Officers.

- A. The following officers shall be elected by secret ballot at the Annual Meeting by a majority of the members present or by proxy. They shall serve for a period of one year or until their successors are elected:

President, Vice President, Secretary,
Treasurer, Chairman of Entertainment.

- B. One auditor shall be elected at the Annual Meeting by a majority of the members present, by secret ballot. He shall serve for a period of three years, or until his successor is elected.
- C. Eligible for election are only such members of associations which have joined the Club not less than three months prior to and are present at the meeting of the election, or have given sufficient reason to be excused therefrom.
- D. The Nominating Committee, appointed by the President, shall offer its recommendations for all officers at the regular meeting prior to the Annual Meeting. Other nominations may be made from the floor.
- E. Eligible to vote at the Annual Meeting are only such members who have paid their dues in full for the current year.
- F. In case of vacancy, a new officer shall be elected by vote at the next meeting. In case of sickness or temporary absence, the President shall name an officer pro tem.

Article VI. Dissolution of the Club.

- A. The Club shall not be declared dissolved, nor its assets liquidated, as long as five members vote for the maintenance of the Club.
- B. In case of dissolution, all the Club's assets shall be turned over to the Embassy of Switzerland, Washington, D.C., which shall act as trustee.
- C. If not less than five Swiss organize a new Swiss Club for similar purposes within three years after dissolution of the former Club, they shall receive the full assets of the formerly dissolved Club.
- D. If, after the expiration of three years, another Swiss Club has not been formed, the Swiss Benevolent Society of Washington, D.C., shall receive the full assets of the dissolved Club.

Article VII. Amendments.

- A. Any proposed amendments to this Constitution may be introduced by any member in good standing at any meeting called for this purpose. A two-thirds majority of the members present is required to pass any amendment.

This Constitution shall become operative upon acceptance by at least three Club members.

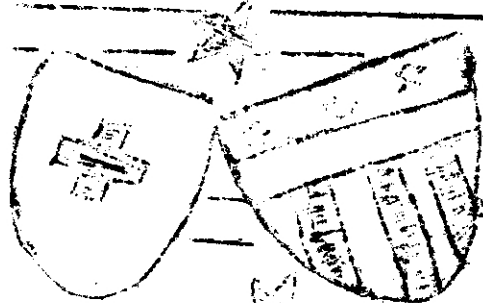

Gentlemen:

Information has been received by this office indicating that you are engaging in operations as a passenger broker, for compensation, in interstate or foreign commerce, without having obtained authority or complying with other provisions of the Interstate Commerce Act.

Section 211 of Part II of the Interstate Commerce Act sets forth:

"(a) No person shall for compensation sell or offer for sale transportation subject to this part or shall make any contract, agreement, or arrangement to provide, procure, furnish, or arrange for such transportation or shall hold himself or itself out by advertisement, solicitation, or otherwise as one who sells, provides, procures, contracts, or arranges for such transportation, unless such person holds a broker's license issued by the Commission to engage in such transactions."


Specifically, this office has received information to the effect that you held out to the general public by placing an advertisement in The Pittsburgh Press of Sunday, August 30, 1970, to provide round-trip motor carrier transportation from Pittsburgh, Pa. to Monroe, Wisconsin and return for an undisclosed amount of compensation. The information indicates that the transportation referred to above occurred over the weekend of September 5th, 6th and 7th, 1970.

In a number of instances brokers arranging transportation of passengers in interstate commerce by motor vehicle and not holding proper authority under Part II have been charged and convicted in criminal proceedings for operating in violation of the provisions of the Interstate Commerce Act or the regulations of the Interstate Commerce Commission.

An acknowledgment of this letter is requested not later than September 24, 1970, setting forth your future intentions in the premises.

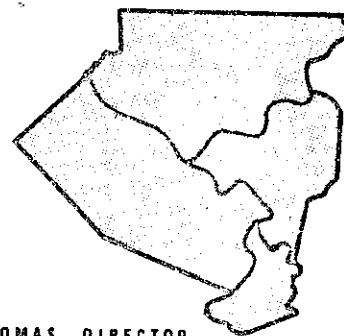
