Evaluation of Employment Possibilities for
FLIGHT ATTENDANTS (Hostesses and Stewards)
in North America

During the last few years, SWISSAIR has considerably increased its production. In North America alone, following the first direct flight to Los Angeles in November 1989, we now serve seven destinations, i.e. New York, Boston, Chicago, Atlanta, Los Angeles, Montreal and Toronto. On all of these routes, we exclusively use wide-body aircraft such as the "Jumbo" (B747) and the DC-10. Towards the end of this year, SWISSAIR will be among the first carriers to fly the newest aircraft on the market, the MD-11.

This increase in production obviously necessitates an increase in personnel, especially in cabin crew. The North Atlantic routes alone require approximately 300 hostesses and stewards per day.

This is why SWISSAIR is presently evaluating the possibility of recruiting Flight Attendants in North America, preferably from the New York, Boston and Chicago areas.

The ideal qualifications for Flight Attendants would be:

- High School education and a professional experience in any kind of business or trade
- between 20 and 30 years of age
- apart from English, fluency in German or French, or even in both
- American citizenship or holder of a Green Card

Since we would prefer our Flight Attendants to have a close relationship to Switzerland, we wanted to give priority to members of Swiss communities in the United States. However, it is extremely difficult for us to evaluate the potential of such qualified candidates.

Therefore, we take the liberty to address this circular letter to you.

We would very much appreciate if you could assist us in this evaluation, and let us have an approximate number of potential candidates fulfilling the above requirements from the members of your organization.

However, please be aware that the recruitment of Flight Attendants is only at the evaluation stage for the time being. Your members, therefore, should not be encouraged to submit applications for employment. Only upon receipt of your information, will we be able to decide whether this project can be realized or not.

Attached is an information sheet for your input. We would be grateful to have your response by February 28, 1990.

Meeting of the Board of Directors

The board met at 7:30 at the home of Henry and Pat Heer.

The purpose of the meeting was to sketch out plans for 1990 activities, especially the spring business meeting and selection of a restaurant for the Christmas dinner.

Hazel called the meeting to order at 7:40 PM. The minutes were read by Nancy; they consisted of comments about the Christmas dinner meeting, especially some problems encountered which we would like to avoid in the future. Regarding the issue of having paid for the no-show's dinners, we should remember to specifically ask for the extra food if this happens again. The secretary's report was accepted as read.

Since Treasurer Florence Jacob was not there, Hazel gave the Treasurer's report. Again, the holiday dinner realized a great profit: \$147.34 for the dinner and \$87.38 for the tombola. It was also noted that we should wait a couple of months before arranging for these musicians and singers, just in case a once-in-a-lifetime opportunity should arise to catch a traveling Swiss band coming through the country.

Betty suggested inviting the Altoona Swiss to the picnic. Pat will find out whom to contact there.

Betty mentioned that the cakes went over very well at the last picnic, and everyone agreed that it would be a good idea to try again; we will get several volunteers who will each bake a cake or two.

There was a strong feeling that this year we should try having traditional Swiss food. Hazel will contact Schaller to see if he is willing to do the catering.

4. John read a letter about a Swiss opera group which performs in Romanisch, and will be touring the U.S. during the summer of 1991. They are requesting assistance from Swiss clubs in terms of possible lodging arrangements, and in helping them contact possible sponsors, such as universities with departments of romance language or music. Several suggestions were brought up: a/ ask Fred to speak to someone at CMU; b/ forward the letter to Heinz Kunz for the CH-91 committee; c/ contact Slippery Rock College, where someone had previously contacted Betty because of an interest in the Romanisch language. Nancy took the letter.
5. John read a letter from the Swiss Institute in New York, soliciting donations/memberships for its cultural programs. It was decided that a response from a club such as ours was inappropriate; it was more directed toward individuals.
6. Spring Meeting. We selected Jack's again for the location of the meeting; Hazel will contact them. Saturday, May 19th was selected as the date. Another board meeting in March will be dedicated to more detailed planning of this meeting.
7. A letter from the Boston Swiss American Society was read, offering Swiss/American flag pins for sale. We decided to buy 100, and if they sell quickly before the deadline of July 31, we will order more.
8. Swissair. A letter from Swissair was read, which requested statistical information regarding our population of Swiss-Americans between 20 and 30 years of age who might be candidates for flight attendants and stewards when Swissair's routes increase in the U.S. Nancy will respond with an estimate. It was noted that we have very few people in this age group.
9. Sami Klaus party. Betty would like to try again to plan a children's party, probably on December 9th. It would involve the Kinderchor, the Lustigen Iserthalers, and the Schuhplaettler, along with Santa and gifts. Mr. Grossman has offered to help us obtain a location for this event at Skibo Hall at CMU, free of charge.

Another possible event Betty would like to get together is a Swiss night at the Teutonia.

Dear Ladies and Gentlemen,

We would like to present a musical project to you, and ask you if you would be interested in participating with us to organize a tour of the U.S.A. in summer of 1991. In August of 1988 as part of a cultural festival of Swiss Romanish people, the opera Il President da Valdei (The Mayor of Valdei) was performed for the first time. Subsequently, in February 1989 a recording was made in the recording studios of the Swiss National Radio in Zürich. The circa one hour chamber opera, set for 5 singers and 8 instrumentalists, deals with the conflicts between traditional ways and new ideas in a village in the Grisons (a canton, or state in Switzerland). The composer of this opera is an American, who has settled in the mountains of Switzerland where Romanish is spoken. The story is taken from a novel of Gian Fontana, who is one of the most famous of Swiss romanish writers.


Now the idea has come up that during the celebration of the 700 year anniversary of the Swiss Confederation a tour of this opera in North America by a group of Swiss musicians and singers would strengthen the cultural ties between Switzerland and America, as well as draw attention to the diversity of languages and people in Switzerland. We are tentatively planning performances in cities where there is a Swiss Consulate: Washington, New York, Atlanta, Houston, Los Angeles and San Francisco. Other performances are planned at various Conservatories of Music and Universities with Music Departments. Perhaps the Department of Romance Languages in a University would also be interested in the fact that Romanish (a Latin based language with only 50'000 speakers) is so rarely heard, and would co-sponsor a performance. Financial support would come mainly from Swiss cultural foundations, but some financial help or help with lodging of the musicians (ca. 16 persons) would be greatly appreciated.

In the preparatory stages of this tour to North America it would be most valuable if your institution or club could make a provisional confirmation or show a strong interest in bringing a performance to your city. Of course any financial support would be prominently indicated in the specially printed program for the opera.

If you are interested, please contact us as soon as possible and we will send the complete documentation for the opera, as well as a cassette recording.

A limited edition of 600 numbered copies in two volumes, the work contains over 1,100 pages and over 775 halftones, maps, and coats of arms. It measures 8½ by 11 inches with hardbound cover and dust jacket. The book is set in Schoolbook and printed on 70-pound Javelin Gloss Enamel. The halftones were shot using a 150-dot line screen.

The work is divided into four sections:

Section I Whence Did They Come?

A brief history of Switzerland from its founding in 1291 to the present and of the Canton of Vaud from its beginning in 1803.

Section II What Brought Them To Tennessee? And What Did They Find?

Tells why they settled in East Tennessee and what life was like for them during the Civil War. Also includes some of the various contributions the French-Swiss have made to Knoxville.

Section III The Religion In Which They Trusted

A brief history of the Christian faith in Switzerland from the fourth century to the present. It is divided into four chapters which detail the history of the Open Brethren and the Plymouth Brethren in Switzerland and Knoxville.

Section IV Their Lives Our Heritage

Divided into 32 chapters which include the biographies and genealogies of the different French-speaking Swiss families. Each chapter begins with the family coat of arms. The 35 families included:



The Helvetia Society of Pittsburgh was a continuation of membership for Swiss chefs, pastry chefs and cooks. Membership was granted from the original organization in Switzerland. Dues were paid and some benefits were included.

There were few Swiss here so associate membership was granted to other nationalities. There were French, German and Italian members and Americans. The charter did not permit anyone other than a Swiss to be president which was not appreciated by non-Swiss.

For many years the Helvetia society here had two big affairs each year. The "Swiss Ball" was held in the fall of the year, first in the English room of the Fort Pitt Hotel and later in the Ballroom of the William Penn Hotel. The members made beautiful food displays, decorated hams, turkeys, cakes and even ice carvings. The foods were raffled off and made extra entertainment. There was always a large crowd, dancing to fine orchestras and renewal of friendships.

The second affair was a summer picnic, held in parks. North Park Lodge became a favorite spot. H.J. Heinz company was very generous and permitted use of big pans and cooking of food, even a van to transport. Ervin Hainisch and Walter Muntwyler and their crew did all the preparation and clean up.

We all looked forward to these two big affairs, and I believe we would not have had a cohesive Swiss society except for these affairs. When the Helvetia Society in Switzerland abandoned the society, there was little activity until Florence Gerber Cappe organized the Swiss into an active organization and once again we had our annual picnic and Christmas dinner. Sam Gerber was owner of Cranberry Hall and Christmas dinner and party were held there until Sam sold the business and we found other places.

Many of the members of the Swiss-American Society are second and third generation or non-Swiss except by marriage. I believe our society has fostered a pride in our heritage and with air travel, many have made personal visits to meet our Swiss relatives and to take pride in our heritage.

We are particularly grateful for your efforts in taking the time to assist us in our evaluation and for returning the survey form in due course.


