ANNUAL BUSINESS MEETING AND CHRISTMAS DINNER DEC. 5, 1993

SEVENTY FOUR MEMBERS ATTENDED THE ANNUAL BUSINESS MEETING AND XMAS DINNER HELD ON SUNDAY, DECEMBER 5, 1993 AT TIVOLI'S RESTAURANT IN PENN HILLS.





Treasurers Report - December 1, 1992
to November 30, 1993

At the beginning of our fiscal year December 1, 1992, we carried forward a balance of \$4,805.61

Our 1992 Holiday Dinner-Business Meeting showed a loss of (33.04) which was more than made up by a profit on the tombola of 116.47

Our Sami Klaus Party came in with a loss of (104.94)

Our Spring Luncheon had a loss of (84.59)

Our First of August celebration had a loss of (72.36) but a profit on the First of August Tombola of 135.34

Our Bus Trip showed a profit of 7.35

We ended the year with a balance of \$4,177.43. This figure has been adjusted by \$1,095--the money we have in our account for this party.

Heer to purchase for us seven poinsettias, and Conrad Ostertag will purchase five trukeys. Other prizes will be solicited from the general membership.

The subject of diminished dues coupled with incidentals like low interest rates, account management fees, postage overage on some of our mailings, increased cost of minor purchases, etc. prompted a discussion regarding a possible increase in dues. There was a consenses that we try other means before we think of a dues raise. Many ideas were expressed--including a page of business card-size ads in our newsletter. This idea is to be discussed with President Rolf Kuehni at our next Board Meeting. It was moved by Joseph Gigandet and seconded by Conrad Ostertag that we place an article in "Switzerland" asking for patron donations with an explanation of why it is necessary to do so. 
Dr. Kunz told of the Pellegrini Student Exchange Program which is now available to high school students in Pennsylvania.

Dear Mr. Heer,

We are close (the same state) yet far 300 miles. We are both Swiss organizations. Are we similar or different?

The S. B. S. of Philadelphia was formed in 1860 to care for needy Swiss when ever and where ever we could. We are fortunate that we have few Swiss who have fallen on bad times of late.

In an effort to be of service to Swiss and descendants of Swiss we have joined forces with the S. B. S. in New York who had formed a separate group called the Pellegrini Fund to assist needy students of Swiss descent. Originally the fund covered students from New York, New Jersey and Connecticut. At our request and accompanied by a donation the area was enlarged to include all of Pennsylvania and Delaware. Last year we had nine applicants from Pa. None from Delaware. Even though most all of our members are from the greater Philadelphia and southern N J area we decided to include all of Pa. since to draw a line anywhere was difficult and could be unfair. The nine applicants were granted \$9,500.00 out of the pool of some \$60,000.00 from the Pellegrini fund. The Pellegrini fund has about \$850,000.00 in assets. The \$60,000 to \$70,000 given each year is derived from dividends.

We joined with the larger group for two reasons. First with their larger assets we would not run out of money down the line if we get more applications. Second to start our own plan even with help could be costly and had the potential for errors that have already been taken care of by the larger more experienced Pellegrini fund. Last year we donated \$8,500.00 to the fund.

Are you involved in anything like this? Would you consider joining with us to enlarge the amount available to students from Pa?

Please tell me something about your group. Perhaps we could visit one of your meetings some time. Let me hear from you.
